March 10-14, 2025

With growing global threats to American interests and values, this is a critical moment for Americans to speak out on the imperative for strong U.S. leadership on the international global stage.

It's why business and faith leaders, veterans, farmers, NGOs, implementers, and local elected and community leaders from around the country are joining together from March 10-14, 2025 to take action in support of U.S. international assistance.

Please join us in urging Congress to protect U.S. international assistance, global health, and humanitarian programs that save lives and make America #SaferStronger and more prosperous.

Why Now?

The Trump Administration has gutted U.S. international assistance programs around the world.

Smart, cost-effective investments in U.S. international assistance programs help prevent conflicts and the spread of deadly disease; deliver lifesaving food, medicine, and shelter to people in need; foster self-reliance; curb illegal migration and drug trafficking; and enable America to outcompete rivals like China, Russia, and Iran.

The abrupt cutoff of these critical programs actively undermines U.S. interests, and our adversaries are stepping into the vacuum. This has not only put the lives of tens of millions of people around the world at risk, it also poses a clear and present danger to American lives and livelihoods and to U.S. strategic interests around the world.

As the fallout of the current shutdown and termination of programs becomes more clear, it is critical for Congress and the Administration to restore U.S. international assistance programs that are lifesaving and advance American interests.

Now is the time to urge Members of Congress that you, as their constituent, believe that U.S. international assistance makes America #saferstronger and more prosperous.

Call on the Administration to reverse the termination of U.S. international assistance programs and resume the disbursement of Congressionally appropriated foreign assistance funds

Provide robust oversight and accountability of U.S. foreign assistance programs and ensure a careful review that preserves and strengthens programs that save lives and advance our national security and economic interests
